LISTING AGREEMENT FORM
APPENDIX B to REGULATION 2
(Regulations 2.1 (v) and 2.5)

AGREEMENT made this _____ day of _____ 20

By _____ a Company duly formed and registered under the Indian Companies Act and having its Registered Office in _____ (hereinafter called "the Company") with AHMEDABAD STOCK EXCHANGE LTD. (hereinafter called "the Exchange").

WITNESSETH:

WHEREAS the Company has filed with the Exchange an application for listing its securities more particularly described in Schedule I annexed hereto and made a part hereof.

AND WHEREAS it is a requirement of the Exchange that there must be filed with the application an agreement in terms hereinafter appearing to qualify for the admission and continuance of the said securities upon the list of the Exchange.

NOW THEREFORE in consideration of the Exchange listing the said securities, the Company hereby covenants and agrees with the Exchange as follows:

1. The Company agrees-
 - (a) that Letters of Allotment will be issued simultaneously and that in the event of its being impossible to issue Letters of Regret at the same time a notice to that effect will be inserted in the press so that it will appear on the morning after the day on which the Letters of Allotment have been posted;
 - (b) that Letters of Right will be issued simultaneously;
 - (c) that Letters of Allotment, Acceptance or Rights will be serially numbered, printed on good quality paper and examined and signed by a responsible officer of the Company and that whenever possible they will contain the distinctive numbers of the securities to which they relate;
 - (d) that Letters of Allotment and renounceable Letters of Right will contain a provision for splitting and that when so required by the Exchange, the form of renunciation will be printed on the back of or attached to the Letters of Allotment and Letters of Right;
 - (e) that Letters of Allotment and Letters of Right will state how the next payment of interest or dividend on the securities will be calculated.

2. The Company will issue, when so required, receipts for all securities deposited with it whether for registration, sub-division, exchange or for other purposes.

3. The Company agrees -
 - (a) to have on hand at all times a sufficient supply of certificates to meet the demands for transfer, subdivision and consolidation;
 - (b) to issue certificates or Pucca Receipts within three months of the date of the expiration of any

- Right of Renunciation;
- (c) to issue certificates within one month of the date of the lodgment of a transfer or to issue within fifteen days of such lodgment Pucca Transfer Receipts autographically signed by a responsible official of the Company and bearing an endorsement that the transfer has been duly approved by the Directors or that no such approval is necessary;
 - (d) to issue without charge Balance Certificates within one month, if so required;
 - (e) to issue new certificates in replacement of those which are lost, forthwith, upon notification of loss and receipt of proper indemnity.
- *4. The Company agrees
- (a) to split certificates, Letters of Allotment, Letters of Right and Pucca Transfer Receipts of large denominations into smaller units;
 - (b) to consolidate certificates of small denominations into units corresponding to those fixed by the Exchange for market trading;
 - (c) to issue Split Receipts and Consolidation Receipts duly certified by an official of the Company, particularly when so required by the Exchange;
 - (d) to exchange 'Right' or 'Entitled' shares into Coupons or Fractional Certificates when so required by the Exchange.
 - * (e) to issue a single share certificate to an investor, who wishes to obtain physical share certificates unless otherwise specifically requested by him, in case of an IPO." [*Amended vide SEBI Circular no. SMDRP/Policy/Cir-12/01 dated. 28-02-2001]
5. When documents are lodged for sub-division or consolidation through the Clearing House of the Exchange, the Company agrees-
- (a) that it will accept the discharge of an official of the Stock Exchange Clearing House on the Company's Split Receipts and Consolidation Receipts as good and sufficient without insisting on the discharge of the registered holders;
 - (b) that when the Company is unable to issue certificates or Split Receipts or Consolidation Receipts immediately on lodgment, it will verify whether the discharge of the registered holders on the documents lodged for sub-division or consolidation and their signatures on the relative transfers are in order.
- *5A. For shares issued pursuant to the public issues or any other issue which remain unclaimed and are lying in the escrow account, the issuer agrees to comply with the following procedure:
- (a) The registrar to the issue shall send at least three reminders at the address given in the application form as well as captured in depository's database asking for the correct particulars. If no response is received, the unclaimed shares shall be credited to a demat suspense account with one of the Depository Participants, opened by the issuer for this purpose.
 - (b) Any corporate benefits in terms of securities accruing on such shares viz. bonus shares, split etc., shall also be credited to such demat suspense account.
 - (c) The issuer shall maintain details of shareholding of each individual allottee whose shares are credited to such suspense account.
 - (d) As and when the allottee approaches the issuer, the issuer shall credit the shares lying in the suspense account to the demat account of the allottee to the extent of the allottee's entitlement after proper verification of the identity of the allottee.
 - (e) The suspense account shall be held by the issuer purely on behalf of the allottees who are entitled for the shares and the shares held in such suspense account shall not be transferred in any manner whatsoever except for the purpose of allotting the shares to the allottee as and when he/she approaches the issuer.
 - (f) The voting rights on such shares shall remain frozen till the rightful owner claims the shares.

(g) The issuer shall disclose the following details in its Annual Report, as long as there are shares in the suspense account :

- (i) Aggregate number of shareholders and the outstanding shares in the suspense account lying at the beginning of the year;
- (ii) Number of shareholders who approached issuer for transfer of shares from suspense account during the year;
- (iii) Number of shareholders to whom shares were transferred from suspense account during the year;
- (iv) aggregate number of shareholders and the outstanding shares in the suspense account lying at the end of the year;
- (v) that the voting rights on these shares shall remain frozen till the rightful owner of such shares claims the shares [*** Inserted vide SEBI Circular No. SEBI/CFD/DIL/LA/1/2009/24/04 dated 24.04.2009**].

6 The Company will, if so required by the Exchange, certify transfers against Letters of Allotment, certificates and Balance Receipts and in that event the Company will make on transfers an endorsement to the following effect:

“Name of Company _____ Certificate/Allotment Letter No. _____ for the within-mentioned _____ shares is deposited in the Company’s Office against this transfer No. _____ Signature (s) of Official (s) _____ Date _____”.

7. On production of the necessary documents by shareholders or by members of the Exchange, the Company will make on transfers an endorsement to the effect that the Power of Attorney or Probate or Letters of Administration or Death Certificate or Certificate of the Controller of Estate Duty or similar other document has been duly exhibited to and registered by the Company.

8. The Company agrees that it will not make any charge

- (a) for issue of new certificates in replacement of those which are old, decrepit or worn out or where the cages on the reverse for recording transfers have been fully utilized;
- (b) for registration of any Power of Attorney, Probate, Letters of Administration or similar other documents.

9. The Company agrees that it will not charge any fees exceeding those which may be agreed upon with the Exchange (existing transfer fees of this Company are agreed upon)

- (a) for issue of new certificates in replacement of those that are torn, defaced, lost or destroyed;
- (b) for registration of transfers of its shares or debentures;
- (c) for splitting or consolidating share or debenture certificates;
- (d) for splitting Letters of Allotment, renounceable Letters of Right and Pucca Transfer Receipts.

10. The Company will verify the signatures of shareholders on Allotment Letters, Split, Consolidation, Transfer and any other Temporary Receipts and transfer deeds when so required by the shareholders or a member of the Exchange or by the Stock Exchange Clearing House. Such verification shall be by a duly authorised officer of the company whose name and specimen signature shall be supplied by the company to the Exchange from time to time.

11. The Company agrees that it will entertain applications for registering transfer of its securities when-

- (a) the instrument of transfer is in any usual or common form approved by the Exchange; and
- (b) the transfer deeds are properly executed and accompanied either by certificates or by Letters of Allotment, Pucca Transfer Receipts, Split Receipts or Consolidation Receipts duly discharged either by the registered holders or, in the case of Split Receipts and Consolidation Receipts, by an official of the Stock Exchange Clearing House as provided herein.

* (c) Transferees(s) furnish copy of their PAN card to the Company / RTA’s for registration of transfer of shares, for securities market transaction and off-market/private transaction involving transfer of shares in physical form. (*** Inserted vide SEBI Circular No.**

12. On lodgment of the proper documents, the Company agrees that it will register transfers of its securities in the name of the transferee except-
- (a) when the transferee is, in exceptional circumstances, not approved by the Directors in accordance with the provisions contained in the Articles of Association of the Company, in which event the President of the Exchange may be taken into confidence, if so requested, as to the reasons for such rejection;
 - (b) when any statutory prohibition or any attachment or prohibitory order of a competent authority restrains the Company from transferring the securities out of the name of the transferor;
 - (c) when a transferor objects to the transfer provided he serves on the Company within a reasonable time a prohibitory order of a Court of Competent jurisdiction.
- 12A (1) The Company agrees that when proper documents are lodged for transfer and there are no malpractice / defects in the documents except minor difference in signature of the transferor(s).
- (i) then the Company will promptly send by Registered Post to the first transferor an intimation of the aforesaid defect in the documents, and inform the transferor that objection, if any, of the transferor supported by valid proof, is not lodged with the Company within fifteen days of receipt of the Company's Letter, then the securities will be transferred;
 - (ii) if the objection from the transferor with supporting documents is not received within the stipulated period, the Company shall transfer the securities provided the Company does not suspect fraud or forgery in the matter;
- *(1a) "The company agrees that in respect of transfer of shares where the company has not effected transfer of shares within 1 month or where the company has failed to communicate to the transferee any valid objection to the transfer within the stipulated time period of 1 month, the company shall compensate the aggrieved party for the opportunity losses caused during the period of the delay.
In addition, the company keeping in view the provisions of section 206A of the Companies Act, 1956 and section 27 of the Securities Contracts (Regulation) Act, 1956, provide all benefits (i.e. bonus shares, right shares, dividend) which accrued to the investor during the intervening period on account of such delay." **[*Amended vide SEBI letter no. - (2) The Company agrees that when the signature of transferor(s) is attested by a person authorised by the Department of Company Affairs, u/s 108 (I A) of the Companies Act, 1956 then it shall not refuse to transfer the securities on the ground of signature difference unless it has reasons to believe that a forgery or fraud is involved.[* **Amended vide SEBI Letter No. SED/4606/95 dated 7/12/95]**
13. The Company will promptly notify the Exchange of any attachment or prohibitory orders restraining the Company from transferring securities out of the names of the registered holders and furnish to the Exchange particulars of the number of securities so affected, the distinctive numbers of such securities and the names of the registered holders thereof.
14. If, in view of the volume of business in the listed securities of the Company, the Exchange so requires, the Company will arrange to maintain-
- (a) a transfer register in the City of Ahmedabad on which all securities of the Company that are listed on the Exchange would be directly transferable; or
 - (b) a registry office or some other suitable office satisfactory to the Exchange within the City of Ahmedabad which will receive and redeliver all securities there tendered for the purpose of transfer, sub-division or consolidation.
15. The Company agrees that it will not close its Transfer Books on such days (or, when the Transfer Books are not to be closed, fix such date for the taking of a record of its shareholders or debenture holders) as may be inconvenient to the Exchange for the purpose of settlement of transactions, of

which due notice in advance shall have been given by the Company to the Exchange.

- *16. *The Company agrees to close its Transfer Books only once in a year at the time of A.G.M. and to have record dates for other purposes ****or the issue of right or bonus shares, [**the word "right issues" Deleted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**] etc. The company further agrees to have uniform dates of book closing and record dates either on 1st or 16th of any month during the year and *in case of physical scrip, to give to the Exchange notice in advance ***of at least seven working days or of as many days as the Exchange may from time to time reasonably prescribe, stating the date of closure of its Transfer Books (or, when the Transfer Books are not to be closed, the date fixed for taking a record of its shareholders or debenture holders) and specifying the purpose for which the Transfer Books are to be closed (or record is to be taken) and to send copies of such notices to other recognised Stock Exchange in India simultaneously. The company further agrees to give to the Stock Exchange a declaration at the time of fixing the date of Book Closure / Record Date that all the Securities received for transfer one month prior to the date of the intimation of the closure of Register of Members or the Record Date, have been duly transferred and dispatched to the transferees. The company also undertakes that the securities pending for transfer and further securities lodged for transfer will be transferred and dispatched within a period of one month from the date of receipt.

The Company will accept for registration transfers that are lodged with the Company up to the date of closure of the Transfer Books and unless, the Exchange otherwise agrees the Company will defer, until the Transfer Books have reopened, registration of any transfers which may be received after the closure of the Transfer Books.

- *19. The Company will notify the Exchange without delay of the date of the meeting of its Board of Directors at which the recommendation or declaration of a dividend or a right, bonus issue or issue of

convertible debentures carrying a right to subscribe to equity shares or passing over of dividend is due to be considered and will recommend or declare all dividends and/or cash bonus at least five days before commencement of the closure of its transfer books or the record date fixed for the purpose.

"The Company agrees to send prior intimation about the board meeting at which declaration of dividend is due to be considered, at least 7 days in advance.

 - (d) any other information necessary to enable the holders of the listed securities of the Company to appraise its position and to avoid the establishment of a false market in such listed securities.

- *23. The Company agrees
- *(a) to issue or offer in the first instance all shares, (including forfeited shares, unless the Exchange otherwise agrees), securities, rights, privileges and benefits to subscribe to pro-rata to the equity shareholders of the Company unless the shareholders in general meeting decide otherwise; *and to obtain an 'in-principle' approval for listing from the exchanges having nationwide trading terminals where it is listed, before issuing further shares or securities. Where the Company is not listed on any exchange having nationwide trading terminals, it agrees to obtain such 'in-principle' approval from all the exchanges in which it is listed before issuing further shares or securities. **[*Amended vide SEBI Circular no.  - (b) to close the Transfer Books from such date or to fix such record date for the purpose in consultation with the Exchange as may be suitable for the settlement of transactions and to close the Transfer books or fix the record date only after the sanctions subject to which the issue or offer is proposed to be made have been duly obtained unless the Exchange agrees otherwise;
 - (c) to make such issues or offers in a form to be approved by the Exchange and unless the Exchange otherwise agrees to grant in all cases the right of renunciation to the shareholders and to forward a supply of the renunciation forms promptly to the Exchange;
 - (d) to issue, where necessary, coupons or fractional certificates unless the company in general meeting or the Exchange agrees otherwise, and when coupons or fractional certificates are not issued to provide for the payment of the equivalent of the value, if any, of the fractional rights in cash;
 - (e) to give to the shareholders reasonable time, not being less than four weeks, within which to record their interest and exercise their rights;
 - (f) to issue Letters of Allotment or Letters of Rights within six weeks of the record date or date of reopening of the Transfer Books after their closure for the purpose of making a bonus or rights issue and to issue Allotment Letters or certificates within six weeks of the last date fixed by the company for submission of Letters of Renunciation or applications for new securities.
24. (a) A fresh application for listing will be necessary in respect of all new issues desired to be dealt in, provided that, where such new securities are identical in all respects with those already

listed, admission to dealings will be granted on the company intimating to the stock exchange particulars of such new issues

Explanation. —Shares are identical in all respect only if:

- (i) they are of the same nominal value and the same amount per share has been called up;
 - (ii) they are entitled to dividend at the same rate and for the same period, so that at the next ensuing distribution, the dividend payable on each share will amount to exactly the same sum, net and gross; and
 - (iii) they carry the same rights in all other respects.
- (b) The Company agrees to make true, fair and adequate disclosure in the offer documents/draft prospectus/letter of offer in respect of any new or further issue of shares/Securities.
 - (c) The Company agrees that it shall not issue any Prospectus/Offer Document/Letter of Offer for public subscription of any securities unless the said prospectus/offer document/ letter of offer has been vetted by SEBI and an acknowledgement card obtained from SEBI through the lead manager.
 - (d) The Company further agrees that the company shall submit to the exchange the following documents to enable it to admit/list the said securities for dealing in exchange, such as :-
 - (i) A copy of the acknowledgement card letter indicating the observation on draft prospectus/letter of offer/offer documents by SEBI; and
 - (ii) A certificate from a merchant banker acting as a lead manager to the issue reporting positive compliance by the company of the guidelines on disclosure and investor protection issued by SEBI.
 - (e) In the event of non-submission of the documents as mentioned in sub-clause (d) above by the company to the exchange or withdrawal of the acknowledgement card by SEBI at any time before grant of permission for listing/admission to dealing of the securities, the securities shall not be eligible for listing/dealing, as the case may be, and the company shall be liable to refund the subscription money to the respective investors immediately.
 - (f) However, rights issues which are not accompanied by public issue 3 months prior or subsequent to the rights issue closure will not be required to be vetted by SEBI.

39. The Company agrees that in the event of the application for listing being granted such listing shall be subject to the Rules, Bye-laws and Regulations of the Exchange which now are/or hereafter may be in force and the Company further agrees to comply within a reasonable time with such further regulations as may be promulgated by the Exchange as a general requirement for new listings.
40. *(A) **Minimum level of public shareholding [*Amended vide SEBI Circular no. SEBI/ CFD/ DIL/LA/2006/13/4 dtd. 13.04.2006]**
- (i) The company agrees to maintain on a continuous basis, public shareholding of at least 25% of the total number of issued shares of a class or kind, for every such class or kind of its shares which are listed.
 - (ii) Where the company offers or has in the past offered a particular class or kind of its shares to the public to the extent of at least 10% of the issue size in terms of Rule 19(2)(b) of the Securities Contracts (Regulations) Rules, 1957, it agrees to maintain on a continuous basis, public shareholding of at least 10% of the total number of issued shares of such class or kind.
 - (iii) Where the number of outstanding listed shares of any class or kind of the company are two crore or more and the market capitalization of such company in respect of shares of such class or kind is Rs. 1000 crore or more, it agrees to maintain on a continuous basis, public shareholding of at least 10% of the total number of issued shares of such class or kind.
 - (iv) Where, as on May 1, 2006, the shares of a particular class or kind issued by the company are listed and the public shareholding in respect of shares of such class or kind is less than 25% or 10%, as the case may be, of the total number of issued shares of such class or kind, the company agrees to increase public shareholding in respect of shares of such class or kind to 25% or 10%, as the case may be, within such period as may be approved by the Specified Stock Exchange (SSE) but not exceeding two years from the said date.

Provided that the SSE may, on an application made by the company and after satisfying itself about the adequacy of steps taken by the company to increase its public shareholding and genuineness of the reasons submitted by the company for not reaching the minimum level of public shareholding and after recording reasons in writing, extend the time for compliance with the requirement of minimum level of public shareholding by a further period not exceeding one year.

- (v) Where the public shareholding in a company in respect of shares of such class or kind is less than 25% or 10%, as the case may be, of the total number of issued shares of such class or kind, the company agrees not to dilute in any way its public shareholding, except for supervening extraordinary events, including , but not limited to events specified in sub-clause (vii) of Clause 40A, with the prior approval of the SSE.
- (vi) The company agrees not to make any allotment of its shares to its promoters or entities belonging to its promoter group , except on account of supervening extraordinary events, including, but not limited to events specified in subclause (vii) of Clause 40A, or make any offer to buyback its shares or buy its shares for the purpose of making sponsored issuance of depository receipts or take any other step, including issuance of depository receipts, if it results in reducing the public shareholding below the minimum level of 25% or 10%, as the case may be.
- (vii) Where the public shareholding in any class or kind of shares of a company falls below the minimum level of public shareholding on account of supervening extraordinary events , including, but not limited to -
- (a) issuance or transfer of shares in compliance with directions of a regulatory or statutory authority or court or tribunal;
 - (b) issuance or transfer of shares in compliance with the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 1997;
 - (c) re-organization of capital by way of a scheme of arrangement; and
 - (d) issuance or transfer of shares under a restructuring plan approved in compliance with the Corporate Debt Restructuring System laid down by the Reserve Bank of India,

the SSE may, after examining and satisfying itself about the circumstances of the case and after recording reasons in writing, extend the time for compliance with the requirement of minimum level of public shareholding by a further period not exceeding one year.

Provided that the SSE may, on an application made by the company and after satisfying itself about the adequacy of steps taken by the company to increase its public shareholding and genuineness of the reasons submitted by the company for not reaching the minimum level of public shareholding and after recording reasons in writing, extend the time for compliance with the requirement of minimum level of public shareholding by a further period not exceeding one year.

- (viii) The company agrees that in the event of sub-clauses (iv) or (vii) becoming applicable, it shall forthwith adopt any of the following methods to raise the public shareholding to the minimum level:
- (a) issuance of shares to public through prospectus;
 - (b) offer for sale of shares held by promoters to public through prospectus;
 - (c) sale of shares held by promoters through the secondary market; or
 - (d) any other method which does not adversely affect the interest of minority shareholders.

Provided that for the purpose of adopting methods specified at sub-clauses (c) and (d) above, the company agrees to take prior approval of the SSE which may impose such conditions as it deems fit.

- (ix) Where a company fails to comply with this clause, its shares shall be liable to be delisted in terms of the Delisting Guidelines / Regulations, if any, prescribed by SEBI in this regard and the company shall be liable for penal actions under the Securities Contracts (Regulation) Act, 1956 and the Securities and Exchange Board of India Act, 1992.
- (x) Nothing contained in sub-clauses (i) to (vii) shall apply to –
- (a) a company in respect of which reference is or has been made to the Board for Industrial and Financial Reconstruction under the Sick Industrial Companies (Special Provisions) Act, 1985 or to the National Company Law Tribunal under Section 424A of the Companies Act, 1956 and such reference is pending or a company in respect of which any rehabilitation scheme is sanctioned by the Board for Industrial and Financial Reconstruction or the National Company Law Tribunal pursuant thereto and is pending full

implementation or any appeal is pending regarding such reference or scheme before the Appellate Authority for Industrial and Financial Reconstruction or National Company Law Appellate Tribunal;

- (b) a government company as defined under Section 617 of the Companies Act, 1956; or,
- (c) an infrastructure company as defined in clause 1.2.1(xv) of the SEBI (Disclosure and Investor Protection) Guidelines, 2000.

Explanation: For the purposes of this clause –

1. The term “market capitalization” shall mean the average market capitalization for the previous financial year. The average shall be computed as the sum of daily market capitalization over one year, divided by the number of trading days. The market capitalization so arrived at shall be considered for the succeeding four quarters.
2. The term “public shareholding” shall exclude –
 - (a) shares held by promoters and promoter group; and
 - (b) shares which are held by custodians and against which depository receipts are issued overseas.
3. The terms “promoter” and “promoter group” shall have the same meaning as is assigned to them under Explanations I, II and III to sub-clause (m) of clause 6.8.3.2 of the SEBI (Disclosure and Investor Protection) Guidelines, 2000.

Provided that for the purposes of Clause 40A, clause (c) of the said Explanation I shall be read as under:

“the person or persons named in the prospectus as promoter(s) or the person or persons named as promoter(s) in the filings with the stock exchanges, whichever is later.”

4. The terms “prospectus” and “Qualified Institutional Buyers” shall have the same meaning as is assigned to them under the SEBI (Disclosure and Investor Protection) Guidelines, 2000.
5. The term “Specified Stock Exchange (SSE)” shall mean -
 - (a) in cases where the company is listed in one stock exchange only, then that stock exchange;
 - (b) in cases where the company is listed in one or more than one stock exchange having nation wide trading terminal and / or in one or more stock exchange not having nation wide trading terminal, then all such stock exchanges having nation wide trading terminals; and
 - (c) in cases where the company is listed in more than one stock exchange and all such stock exchanges do not have nationwide trading terminals, then the stock exchange which was chosen as the Designated Stock Exchange by the company for the previous issue of its shares. Or the regional Stock Exchange, as may be applicable.

(B) Take-over offer

The Company also agrees that it is a condition for continuous listing that whenever a take over offer is made to or by it whether voluntarily or compulsorily, the following requirements shall be fulfilled-

- (1) A public announcement of a take-over offer shall be made both by the offerer or company and the offeree company when—
 - (a) any person in his own name or in the name of any other person acquires, whether by a series of transactions over a period of time or otherwise, securities which, when aggregated with securities already held or acquired by such person, shall carry 10% or more of the total voting rights of the offeree company, or
 - (b) secure the control of management of a company, by acquiring or agreeing to acquire, irrespective of the percentage of the voting capital, the securities of the Directors or other members, who by virtue of their shareholdings together with the shareholdings of their relatives, nominees, family interest and group control or

- manage the company, or
- (2) If the offer is made by a person other than the ultimate offerer the identity of such other person shall be disclosed at the outset in the public announcement as also in the notification to the Stock Exchange.
 - (3) The offer shall be placed, in the first instance before the Board of directors of the offeree company and shall contain the following particulars, namely—
 - (a) detailed terms of offer,
 - (b) identity of the offerer,
 - (c) details of offerer's existing holding in the offeree company.
 - (d) all conditions to which the offer is subject, and
 - (e) confirmation by the auditors of the offerer or that resources available to the offerer or are sufficient to satisfy full acceptance of the offer.
 - (4) All the above information shall be made equally available to all the shareholders (both of the offerer company and the offeree company) at the same time and in the same manner, along with copies of all documents and announcements bearing an offer which shall simultaneously be lodged with SEBI,
 - (5) (a) The offer document (addressed by the offerer company to the offeree company) shall contain the following information—
 - (i) financial information of the offerer company,
 - (ii) intention of the offerer company regarding continuation of the business of the offeree company,
 - (iii) intention of the offerer company regarding any major changes to be introduced in the business of the offeree company,
 - (iv) long term commercial justification of the offerer company for the proposed offer, and
 - (iv) Such other details as may be prescribed by SEBI.

(b) The offer must state the extent to which its directors have interest in the bid.
 - (6) Dealings in any securities by the offerer company or the offeree company and by any of their associates for and on behalf of discretionary investment clients, during an offer period, shall be notified to the Stock Exchange by the respective company.
 - (7) The offerer company shall, either before or immediately after making offer to the offeree company, make an offer to the remaining members of the offeree company to purchase their securities at a price not lower than either the average of highest weekly prices during the immediately preceding 26 weeks from the public announcement of the take over offer or the negotiated price, which ever is higher. This price will be paid by way of cash only.
 - (8) The offer to the remaining shareholders of the transferee company shall be to acquire from them an aggregate minimum of 20 percent, of the total shares of that company. Such offer, however, shall not result in the public shareholding being reduced to less than 20 per cent of the voting capital of the company subject to (10) below.
 - (9) From each of the shareholders accepting such offer, the acquirer shall acquire his full holding up to 100 shares of the face value of Rs. 10 each or up to 10 shares if the face value is Rs. 100.
 - (10) When the Directors of an offeree company sell securities to a purchaser as a result of which the purchaser is required to make an offer, the directors shall ensure that as a condition of the sale, the purchaser undertakes to fulfill his obligations.
 - (11) The Board of Directors of the offeree company shall not, without the approval of the shareholders in General meeting:
 - a) issue any authorised but unissued securities,
 - b) issue any securities carrying rights of conversion into or subscription for securities, or
 - c) sell, dispose of or acquire or agree to sell, dispose of or acquire, assets of a substantial amount.
 - (12) Notwithstanding anything contained in Clause 40A and Clause 40B above, nothing shall apply to acquisition of securities in the company by—
 - 1) Unit Trust of India.
 - 2) SBI Capital Markets Ltd.

- 3) Canbank Financial Services Ltd.
 - 4) LIC Mutual Funds.
 - 5) Such other agencies or mutual funds as may be specified by SEBI from time to time.
 - 6) In pursuance to orders of amalgamations, mergers and acquisitions passed by the Court under section 391 and 394 of the Companies Act.
 - 7) In pursuance to orders passed by the BIFR under Sick Industrial Companies (Special Provisions) Act, 1985.
- (13) The provisions contained in this clause will be without prejudice to the approval required to be obtained under the Companies Act, MRTP Act and Foreign Exchange (Regulation) Act, 1973.
- *(14) The Company further agrees that it is a condition for continued listing that whenever the take-over offer is made or there is any change in the control of the management of the company, the person who secures the control of the management of the company and the Company whose shares have been acquired shall comply with the relevant provisions of the SEBI (Substantial Acquisition of Shares and Take-over) Regulations, 1997.[* Amended Vide Govt. Letter No. 1/57/SE/89 Dtd. 7/8/91 & Amended vide SEBI letter No. SMD/POLICY /CIR-22/97 dt. 8/9/97]

***41. Submission and Disclosure of Interim and Annual Financial Results (*Revised vide SEBI circular no. SEBI/CFD/DIL/LA/3/2007/10/07 dated 10/07/2007)**

The company agrees to comply with the revised provisions of submission and disclosure of Interim and Annual Financial results as prescribed by SEBI vide circular no. **SEBI/CFD/DIL/LA/3/2007/10/07 dated 10/07/2007**

I) Preparation and Submission of Financial Results

- a) The financial results filed and published in compliance with this clause shall be prepared on the basis of accrual accounting policy and in accordance with uniform accounting practices adopted for all the periods.
- b) The company shall submit its quarterly, year to date and annual financial results to the stock exchange in the manner prescribed in this clause.
- c) The company has an option either to submit audited or unaudited quarterly and year to date financial results to the stock exchange within one month of end of each quarter (other than the last quarter), subject to the following:
 - (i) In case the company opts to submit unaudited financial results, they shall be subjected to limited review by the statutory auditors of the company (or in case of public sector undertakings, by any practicing Chartered Accountant) and a copy of the limited review report shall be furnished to the stock exchange within two months from end of the quarter.
 - (ii) In case the company opts to submit audited financial results, they shall be accompanied by the audit report.
- d) In respect of the last quarter, the company has an option either to submit unaudited financial results for the quarter within one month of end of the financial year or to submit audited financial results for the entire financial year within three months of end of the financial year, subject to the following:
 - * (i) In case the company opts to submit un-audited financial results for the last quarter, it shall also submit audited financial results for the entire financial year, as soon as they are approved by the Board. Such un-audited financial results for the last quarter shall also be subjected to limited review by the statutory auditors of the company (or in case of public sector undertakings, by any practicing Chartered Accountant) and a copy of the limited review report shall be furnished to the stock exchange within two months from end of the quarter. [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]
 - (ii) In case the company opts to submit audited financial results for the entire financial year, it shall intimate the stock exchange in writing within one month of end of the financial year, about such exercise of option.
- e) If the company has subsidiaries, -

- * (i) it may, in addition to submitting quarterly and year to date stand alone financial results to the stock exchange under item (c) i.e. within one month of the end of the quarter, also submit quarterly and year to date consolidated financial results within two months from the end of the quarter; and [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]
- (ii) while submitting annual audited financial results prepared on stand-alone basis under item (c), it shall also submit annual audited consolidated financial results to the stock exchange.
- f) The financial results covered under this sub-clause shall be submitted to the stock exchange within fifteen minutes of conclusion of the meeting of the Board or Committee in which they were approved pursuant to sub-clause (II), through such mode as may be specified by the stock exchange.

II) Manner of approval and authentication of the financial results

- a) The quarterly financial results submitted under sub-clause (I) shall be approved by the Board of Directors of the company or by a committee thereof, other than the audit committee. Provided that when the quarterly financial results are approved by the Committee they shall be placed before the Board at its next meeting: Provided further than while placing the financial results before the Board, the Chief Executive Officer and Chief Financial Officer of the company, by whatever name called, shall certify that the financial results do not contain any false or misleading statement or figures and do not omit any material fact which may make the statements or figures contained therein misleading.
- b) The Committee mentioned in item (a) above shall consist of not less than one third of the directors and shall include the managing director and at least one independent director.
- c) The financial results submitted to the stock exchange shall be signed by the Chairman or managing director, or a whole time director. In the absence of all of them, it shall be signed by any other director of the company who is duly authorized by the Board to sign the financial results.
- *d) The limited review report mentioned in sub-clause (I) (c)(i) shall be placed before the Board of directors or the Committee mentioned in item (b) above, before being submitted to the stock exchange where the variation {as mentioned in Clause 41 (IV) (a)} between unaudited financials and financials amended pursuant to limited review for the same period, exceeds 10%.

Provided that when the limited review report is placed before the Committee they shall also be placed before the Board at its next meeting. [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]

- e) The annual audited financial results shall be approved by the Board of Directors of the company and shall be signed in the manner specified in item (c).

III) Intimation of Board Meeting

- a) The company shall give prior intimation of the date and purpose of meetings of the Board or Committee in which the financial results will be considered under sub-clause (II)(a) or (II)(e), as the case may be, at least seven clear calendar days prior to the meeting (excluding the date of the intimation and date of the meeting).
- b) The company shall also simultaneously issue a public notice in at least in one English daily newspaper circulating in the whole or substantially the whole of India and in one daily newspaper published in the language of the region, where the registered office of the company is situated.

IV) Other requirements as to financial results

- a) Where there is a variation between the unaudited quarterly or year to date financial results and the results amended pursuant to limited review for the same period, and –

- (i) the variation in net profit or net loss after tax is in excess of 10% or Rs.10 lakhs, whichever is higher; or
 - (ii) the variation in exceptional or extraordinary items is in excess of 10% or Rs.10 lakhs, whichever is higher - the company shall submit to the stock exchange an explanation of the reasons for variations, while submitting the limited review report. The explanation of variations so submitted shall be approved by the Board of Directors: Provided that in case of results for the last quarter, the above sub-clause shall apply in respect of variation, if any, between the year to date figures contained in the unaudited results and the figures contained in the annual audited results.
- b) If the auditor has expressed any qualification or other reservation in respect of audited financial results submitted or published under this clause, the company shall disclose such qualification or other reservation and impact of the same on the profit or loss, while publishing or submitting such results.
- c) If the auditor has expressed any qualification or other reservation in his audit report or limited review report in respect of the financial results of any previous financial year or quarter which has an impact on the profit or loss of the reportable period, the company shall include as a note to the financial results –
- (i) how the qualification or other reservation has been resolved; or
 - (ii) if it has not been resolved, the reason therefore and the steps which the company intends to take in the matter.
- d) If the company has changed its name suggesting any new line of business, it shall disclose the net sales or income, expenditure and net profit or loss after tax figures pertaining to the said new line of business separately in the financial results and shall continue to make such disclosures for the three years succeeding the date of change in name. Provided that tax expense shall be allocated between the said new line of business and other business of the company in the ratio of the respective figures of net profit before tax, subject to any exemption, deduction or concession available under the tax laws.
- e) If the company had not commenced commercial production or commercial operations during the reportable period, the company shall, instead of submitting financial results, disclose the details of amount raised, the portions thereof which is utilized and that remaining unutilized, the details of investment made pending utilisation, brief description of the project which is pending completion, status of the project and expected date of commencement of commercial production or commercial operations.
- Explanation:** For the purposes of this item –
- (i) the details mentioned above, shall be approved by the Board or a Committee thereof, based on certification by the Chief Executive Officer and Chief Financial Officer, in compliance with sub-clause (II);
 - (ii) the expression “amounts raised” shall mean the proceeds of any issue of shares or debentures made by the company.
- f) The quarterly and year to date results shall be prepared in accordance with the recognition and measurement principles laid down in Accounting Standard 25 (AS 25 – Interim Financial Reporting) issued by *the Institute of Chartered Accountants of India (ICAI) / Company (Accounting Standards) Rules, 2006, whichever is applicable. [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]
- g) All items of income and expenditure arising out of transactions of exceptional nature shall be disclosed.
- h) Extraordinary items, if any, shall be disclosed in accordance with Accounting Standard 5 (AS 5 – Net Profit or Loss for the Period, Prior Period Items and Changes in Accounting Policies) issued by *the Institute of Chartered Accountants of India (ICAI) / Company (Accounting Standards) Rules, 2006, whichever is applicable. [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]

- i) Changes in accounting policies, if any, shall be disclosed in accordance with Accounting Standard 5 (AS 5 – Net Profit or Loss for the Period, Prior Period Items and Changes in Accounting Policies) issued by *the Institute of Chartered Accountants of India (ICAI) / Company (Accounting Standards) Rules, 2006, whichever is applicable. [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]
- j) Companies, whose revenues are subject to material seasonal variations, shall disclose the seasonal nature of their activities. In addition, they may supplement their financial results with information for the 12 months period ending on the last day of the quarter for the current and preceding years on a rolling basis.
- k) The company shall disclose any event or transaction which occurred during or before the quarter that is material to an understanding of the results for the quarter including but not limited to completion of expansion and diversification programmes, strikes and lock-outs, change in management and change in capital structure. The company shall also disclose similar material events or transactions that take place subsequent to the end of the quarter.
- l) The company shall disclose the following in respect of dividends paid or recommended for the year, including interim dividends: [**the word “(only in respect of annual results)” Deleted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]
 - (i) amount of dividend distributed or proposed for distribution per share; the amounts in respect of different classes of shares shall be distinguished and the nominal values of shares shall also be indicated;
 - (ii) where dividend is paid or proposed to be paid pro-rata for shares allotted during the year, the date of allotment and number of shares allotted, pro-rata amount of dividend per share and the aggregate amount of dividend paid or proposed to be paid on pro-rata basis.
- m) The company shall disclose the effect on the financial results of material changes in the composition of the company, if any, including but not limited to business combinations, acquisitions or disposal of subsidiaries and long term investments, any other form of restructuring and discontinuance of operations.
- n) The company shall also disclose the number of investor complaints pending at the beginning of the quarter, those received and disposed of during the quarter and those remaining unresolved at the end of the quarter.

V) Formats

- a) The quarterly financial results shall be in the format given in Annexure C (I) for companies other than banks and that given in Annexure C (II) for banks.
- *b) Manufacturing, trading and service companies, which have followed functional (secondary) classification of expenditure in the annual profit and loss account published in the most recent annual report or which proposed to follow such classification for the current financial year, may furnish quarterly financial results in the alternative format given in Annexure III. The alternative format can be used only if such format is used consistently from the first quarter of the financial year. [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]
- c) Consolidated financial results shall be in the same format as is applicable to stand-alone financial results. Additionally, details relating to minority interest, share of associates and other related items shall be separately given as additional row items.
- d) Annual audited financial results shall be in the format as is applicable to quarterly financial results. However, columns and figures relating to the last quarter, year to date results and corresponding three months in previous year need not be given.

- e) If the company has more than one reportable primary segment in terms of Accounting Standard 17 (AS 17 – Segment Reporting) issued by ICAI */ Company (Accounting Standards) Rules, 2006, [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**] it shall also submit quarterly or annual segment information as part of financial results in the format given in Annexure C (IV).
- f) Limited review reports shall be given by auditors in the format given in Annexure C (V) for companies other than banks (including those using the alternative format of financial results) and in the format given in Annexure C (VI) for banks.
- g) In case of audited financial reports, the audit report shall be given in the format given in Annexure C (VII) for companies other than banks (including those using the alternative format of financial results) and in the format given in Annexure C (VIII) for banks.

VI) Publication of financial results in newspapers

- a) The company shall, within 48 hours of conclusion of the Board or Committee meeting at which the financial results were approved, publish a copy of the financial results which were submitted to the stock exchange in at least in one English daily newspaper circulating in the whole or substantially the whole of India and in one daily newspaper published in the language of the region, where the registered office of the company is situated: Provided that where the company has opted to submit audited financial results under sub-clause 1(b)(ii), it shall also publish the qualifications or reservations, if any, expressed by the auditor together with the audited results.
- b) Where the company has submitted consolidated financial results in addition to standalone financial results under sub-clause (1) (e), it shall publish only consolidated financial results in the newspapers, subject to the following:
 - (i) It shall intimate the stock exchange in the first quarter of the financial year or within such extended period as may be specified by SEBI in this regard and shall not change the same during the financial year;
 - (ii) In case the company changes its option in any subsequent year, it shall furnish comparable figures for the previous year in accordance with the option exercised for the current year.
 - (iii) It shall give a reference in the newspaper publication, to the places, such as the company's website and stock exchanges' websites, where the standalone results of the company are available". [*** substituted vide SEBI Circular No. SEBI/CFD/DIL/LA/5/2008/4/09 dated 04.09.2008**]

VII) Interpretation

For the purposes of this clause, -

- a) 'financial year' means the period of twelve months commencing on the first day of April every year, subject however to items (e) to (h);
- b) 'annual results' mean the financial results prepared in accordance with this clause in respect of a financial year;
- c) 'quarter' means the period of three months commencing on the first day of April, July, October or January of a financial year, subject however to items (e) to (h);
- d) 'quarterly results' mean the financial results prepared in accordance with this clause in respect of a quarter;
- e) if the duration of financial year of the company is more than 12 months but does not exceed 15 months, there shall be 5 quarters in a financial year;
- f) if the duration of financial year of the company is more than 15 months but does not exceed 18 months, there shall be 6 quarters in a financial year.
- g) the company may at its option have a financial year commencing on a date other than the first day of April;
- h) the company may at its option have quarters commencing on dates other than those mentioned at item (c).

- (2) The statement referred to in clause (1) shall be given for each of the years for which projections are provided in the prospectus/letter of offer/ objects/s stated in the explanatory statement to the notice for considering preferential issue of securities and shall be published in newspapers simultaneously with the unaudited/ audited financial results as required under clause 41.
- (3) If there are material variations between the projections and the actual utilisation/ profitability, the company shall furnish an explanation therefore in the advertisement and shall also provide the same in the Directors' Report. [*Amended vide SEBI Circular no. SMDRP/Policy/Cir-46/2000 dtd. 05.10.2000]

The company agrees to comply with the following provisions:

I. Board of Directors

(A) Composition of Board

- (i) The Board of directors of the company shall have an optimum combination of executive and non-executive directors with not less than fifty percent of the board of directors comprising of non-executive directors.
- (ii) Where the Chairman of the Board is a non-executive director, at least one-third of the Board should comprise of independent directors and in case he is an executive director, at least half of the Board should comprise of independent directors *provided that where the non-executive Chairman is a promoter of the company or is related to any promoter or person occupying management positions at the Board level or at one level below the Board, at least one-half of the Board of the company shall consist of independent directors. [**Inserted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2008/08/04 dated 08/04/2008**]

*“Explanation-For the purpose of the expression “related to any promoter” referred to in sub-clause (ii):

- a. If the promoter is a listed entity, its directors other than the independent directors, its employees or its nominees shall be deemed to be related to it;
- b. If the promoter is an unlisted entity, its directors, its employees or its nominees shall be deemed to be related to it” [**Inserted vide SEBI circular no. SEBI/CFD/DIL/CG/2/2008/23/10 dated 23.10.2008**]

(iii) For the purpose of the sub-clause (ii), the expression ‘independent director’ shall mean a non-executive director of the company who:

- a. apart from receiving director’s remuneration, does not have any material pecuniary relationships or transactions with the company, its promoters, its directors, its senior management or its holding company, its subsidiaries and associates which may affect independence of the director;
- b. is not related to promoters or persons occupying management positions at the board level or at one level below the board;
- c. has not been an executive of the company in the immediately preceding three financial years;
- d. is not a partner or an executive or was not partner or an executive during the preceding three years, of any of the following:
 - i) the statutory audit firm or the internal audit firm that is associated with the company, and
 - ii) the legal firm(s) and consulting firm(s) that have a material association with the company.
- e. is not a material supplier, service provider or customer or a lessor or lessee of the company, which may affect independence of the director; [**The word “and” at the end of this sub-clause is omitted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2008/08/04 dated 08/04/2008**]

f. is not a substantial shareholder of the company i.e. owning two percent or more of the block of voting shares.

g. *is not less than 21 years of age. [*Inserted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2008/08/04 dated 08/04/2008]

Explanation

For the purposes of the sub-clause (iii):

a. Associate shall mean a company which is an “associate” as defined in Accounting Standard (AS) 23, “Accounting for Investments in Associates in Consolidated Financial Statements”, issued by the Institute of Chartered Accountants of India.

b. “Senior management” shall mean personnel of the company who are members of its core management team excluding Board of Directors. Normally, this would comprise all members of management one level below the executive directors, including all functional heads.

c. “Relative” shall mean “relative” as defined in section 2(41) and section 6 read with Schedule IA of the Companies Act, 1956..

(iv) Nominee directors appointed by an institution which has invested in or lent to the company shall be deemed to be independent directors.

Explanation:

“Institution’ for this purpose means a public financial institution as defined in Section 4A of the Companies Act, 1956 or a “corresponding new bank” as defined in section 2(d) of the Banking Companies (Acquisition and Transfer of Undertakings) Act, 1970 or the Banking Companies (Acquisition and Transfer of Undertakings) Act, 1980 [both Acts].”

(B) Non executive directors’ compensation and disclosures

All fees/compensation, if any paid to non-executive directors, including independent directors, shall be fixed by the Board of Directors and shall require previous approval of shareholders in general meeting. The shareholders’ resolution shall specify the limits for the maximum number of stock options that can be granted to non-executive directors, including independent directors, in any financial year and in aggregate.

* “Provided that the requirement of obtaining prior approval of shareholders in general meeting shall not apply to payment of sitting fees to non-executive directors, if made within the limits prescribed under the Companies Act, 1956 for payment of sitting fees without approval of the Central Government.” (*Inserted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2006/13/1 dtd. 13/01/06)

(C) Other provisions as to Board and Committees

(i) The board shall meet at least four times a year, with a maximum time gap of ***four** months between any two meetings. The minimum information to be made available to the board is given in **Annexure– I A**. (*Inserted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2006/13/1 dtd. 13/01/06)

(ii) A director shall not be a member in more than 10 committees or act as Chairman of more than five committees across all companies in which he is a director. Furthermore it should be a mandatory annual requirement for every director to inform the company about the committee positions he occupies in other companies and notify changes as and when they take place.

Explanation:

1. For the purpose of considering the limit of the committees on which a director can serve, all public limited companies, whether listed or not, shall be included and all other companies including private limited companies, foreign companies and companies under Section 25 of the Companies Act shall be excluded.

2. For the purpose of reckoning the limit under this sub-clause, Chairmanship/ membership of the Audit Committee and the Shareholders' Grievance Committee alone shall be considered.

(iii) The Board shall periodically review compliance reports of all laws applicable to the company, prepared by the company as well as steps taken by the company to rectify instances of non-compliances.

(iv) *An independent director who resigns or is removed from the Board of the Company shall be replaced by a new independent director within a period of not more than 180 days from the day of such resignation or removal, as the case may be:

Provided that where the company fulfils the requirement of independent directors in its Board even without filling the vacancy created by such resignation or removal, as the case may be, the requirement of replacement by a new independent director within the period of 180 days shall not apply." [*Inserted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2008/08/04 dated 08/04/2008]

(D) Code of Conduct

(i) The Board shall lay down a code of conduct for all Board members and senior management of the company. The code of conduct shall be posted on the website of the company.

(ii) All Board members and senior management personnel shall affirm compliance with the code on an annual basis. The Annual Report of the company shall contain a declaration to this effect signed by the CEO.

Explanation: For this purpose, the term "senior management" shall mean personnel of the company who are members of its core management team excluding Board of Directors.. Normally, this would comprise all members of management one level below the executive directors, including all functional heads.

II Audit Committee

(A) Qualified and Independent Audit Committee

A qualified and independent audit committee shall be set up, giving the terms of reference subject to the following:

(i) The audit committee shall have minimum three directors as members. Two-thirds of the members of audit committee shall be independent directors.

(ii) All members of audit committee shall be financially literate and at least one member shall have accounting or related financial management expertise.

Explanation 1: The term "financially literate" means the ability to read and understand basic financial statements i.e. balance sheet, profit and loss account, and statement of cash flows.

Explanation 2: A member will be considered to have accounting or related financial management expertise if he or she possesses experience in finance or accounting, or requisite professional certification in accounting, or any other comparable experience or background which results in the individual's financial sophistication, including being or having been a chief executive officer, chief financial officer or other senior officer with financial oversight responsibilities.

(iii) The Chairman of the Audit Committee shall be an independent director;

(iv) The Chairman of the Audit Committee shall be present at Annual General Meeting to answer shareholder queries;

(v) The audit committee may invite such of the executives, as it considers appropriate (and particularly the head of the finance function) to be present at the meetings of the committee, but on occasions it may also meet without the presence of any executives of the company. The finance director, head of internal audit and a representative of the statutory auditor may be present as invitees for the meetings of the audit committee;

(vi) The Company Secretary shall act as the secretary to the committee.

(B) Meeting of Audit Committee

The audit committee should meet at least four times in a year and not more than four months shall elapse between two meetings. The quorum shall be either two members or one third of the members of the audit committee whichever is greater, but there should be a minimum of two independent members present.

(C) Powers of Audit Committee

The audit committee shall have powers, which should include the following:

1. To investigate any activity within its terms of reference.
2. To seek information from any employee.
3. To obtain outside legal or other professional advice.
4. To secure attendance of outsiders with relevant expertise, if it considers necessary.

(D) Role of Audit Committee

The role of the audit committee shall include the following:

1. Oversight of the company's financial reporting process and the disclosure of its financial information to ensure that the financial statement is correct, sufficient and credible.
2. Recommending to the Board, the appointment, re-appointment and, if required, the replacement or removal of the statutory auditor and the fixation of audit fees.
3. Approval of payment to statutory auditors for any other services rendered by the statutory auditors.
4. Reviewing, with the management, the annual financial statements before submission to the board for approval, with particular reference to:

- a. Matters required to be included in the Director's Responsibility Statement to be included in the Board's report in terms of clause (2AA) of section 217 of the Companies Act, 1956
- b. Changes, if any, in accounting policies and practices and reasons for the same
- c. Major accounting entries involving estimates based on the exercise of judgment by management
- d. Significant adjustments made in the financial statements arising out of audit findings
- e. Compliance with listing and other legal requirements relating to financial statements
- f. Disclosure of any related party transactions
- g. Qualifications in the draft audit report.

5. Reviewing, with the management, the quarterly financial statements before submission to the board for approval

***5A** Reviewing, with the management, the statement of uses / application of funds raised through an issue (public issue, rights issue, preferential issue, etc.), the statement of funds utilized for purposes other than those stated in the offer document/prospectus/notice and the report submitted by the monitoring agency monitoring the utilization of proceeds of a public or rights issue, and making appropriate recommendations to the Board to take up steps in this matter. **[*Inserted vide SEBI circular no. SEBI/CFD/DIL/LA/4/2007/27/12 dated 27/12/2007]**

6. Reviewing, with the management, performance of statutory and internal auditors, adequacy of the internal control systems.
7. Reviewing the adequacy of internal audit function, if any, including the structure of the internal audit department, staffing and seniority of the official heading the department, reporting structure coverage and frequency of internal audit.
8. Discussion with internal auditors any significant findings and follow up there on.
9. Reviewing the findings of any internal investigations by the internal auditors into matters where there is suspected fraud or irregularity or a failure of internal control systems of a material nature and reporting the matter to the board.
10. Discussion with statutory auditors before the audit commences, about the nature and scope of audit as well as post-audit discussion to ascertain any area of concern.
11. To look into the reasons for substantial defaults in the payment to the depositors, debenture holders, shareholders (in case of non payment of declared dividends) and creditors.

12. To review the functioning of the Whistle Blower mechanism, in case the same is existing.
13. Carrying out any other function as is mentioned in the terms of reference of the Audit Committee.

Explanation (i): The term "related party transactions" shall have the same meaning as contained in the Accounting Standard 18, Related Party Transactions, issued by The Institute of Chartered Accountants of India.

Explanation (ii): If the company has set up an audit committee pursuant to provision of the Companies Act, the said audit committee shall have such additional functions / features as is contained in this clause.

(E) Review of information by Audit Committee

The Audit Committee shall mandatorily review the following information:

1. Management discussion and analysis of financial condition and results of operations;
2. Statement of significant related party transactions (as defined by the audit committee), submitted by management;
3. Management letters / letters of internal control weaknesses issued by the statutory auditors;
4. Internal audit reports relating to internal control weaknesses; and
5. The appointment, removal and terms of remuneration of the Chief internal auditor shall be subject to review by the Audit Committee

III. Subsidiary Companies

- i. At least one independent director on the Board of Directors of the holding company shall be a director on the Board of Directors of a material non listed Indian subsidiary company.
- ii. The Audit Committee of the listed holding company shall also review the financial statements, in particular, the investments made by the unlisted subsidiary company.
- iii. The minutes of the Board meetings of the unlisted subsidiary company shall be placed at the Board meeting of the listed holding company. The management should periodically bring to the attention of the Board of Directors of the listed holding company, a statement of all significant transactions and arrangements entered into by the unlisted subsidiary company.

Explanation 1: The term "material non-listed Indian subsidiary" shall mean an unlisted subsidiary, incorporated in India, whose turnover or net worth (i.e. paid up capital and free reserves) exceeds 20% of the consolidated turnover or net worth respectively, of the listed holding company and its subsidiaries in the immediately preceding accounting year.

Explanation 2: The term "significant transaction or arrangement" shall mean any individual transaction or arrangement that exceeds or is likely to exceed 10% of the total revenues or total expenses or total assets or total liabilities, as the case may be, of the material unlisted subsidiary for the immediately preceding accounting year.

Explanation 3: Where a listed holding company has a listed subsidiary which is itself a holding company, the above provisions shall apply to the listed subsidiary insofar as its subsidiaries are concerned.

IV. Disclosures

(A) Basis of related party transactions

- (i) A statement in summary form of transactions with related parties in the ordinary course of business shall be placed periodically before the audit committee.
- (ii) Details of material individual transactions with related parties which are not in the normal course of business shall be placed before the audit committee.

(iii) Details of material individual transactions with related parties or others, which are not on an arm's length basis should be placed before the audit committee, together with Management's justification for the same..

(B) Disclosure of Accounting Treatment

Where in the preparation of financial statements, a treatment different from that prescribed in an Accounting Standard has been followed, the fact shall be disclosed in the financial statements, together with the management's explanation as to why it believes such alternative treatment is more representative of the true and fair view of the underlying business transaction in the Corporate Governance Report.

(C) Board Disclosures – Risk management

The company shall lay down procedures to inform Board members about the risk assessment and minimization procedures. These procedures shall be periodically reviewed to ensure that executive management controls risk through means of a properly defined framework.

(D) Proceeds from public issues, rights issues, preferential issues etc.

When money is raised through an issue (public issues, rights issues, preferential issues etc.), it shall disclose to the Audit Committee, the uses / applications of funds by major category (capital expenditure, sales and marketing, working capital, etc), on a quarterly basis as a part of their quarterly declaration of financial results. Further, on an annual basis, the company shall prepare a statement of funds utilized for purposes other than those stated in the offer document/prospectus/notice and place it before the audit committee. Such disclosure shall be made only till such time that the full money raised through the issue has been fully spent. This statement shall be certified by the statutory auditors of the company. Furthermore, where the company has appointed a monitoring agency to monitor the utilization of proceeds of a public or rights issue, it shall place before the Audit Committee the monitoring report of such agency, upon receipt, without any delay. **[*Inserted vide SEBI circular no. SEBI/CFD/DIL/LA/4/2007/27/12 dated 27/12/2007]** The audit committee shall make appropriate recommendations to the Board to take up steps in this matter.

(E) Remuneration of Directors

- (i) All pecuniary relationship or transactions of the non-executive directors vis-à-vis the company shall be disclosed in the Annual Report.
- (ii) Further the following disclosures on the remuneration of directors shall be made in the section on the corporate governance of the Annual Report:
 - (a) All elements of remuneration package of individual directors summarized under major groups, such as salary, benefits, bonuses, stock options, pension etc.
 - (b) Details of fixed component and performance linked incentives, along with the performance criteria.
 - (c) Service contracts, notice period, severance fees.
 - (d) Stock option details, if any – and whether issued at a discount as well as the period over which accrued and over which exercisable.
- (iii) The company shall publish its criteria of making payments to non-executive directors in its annual report. Alternatively, this may be put up on the company's website and reference drawn thereto in the annual report.
- (iv) The company shall disclose the number of shares and convertible instruments held by non-executive directors in the annual report.
- (v) Non-executive directors shall be required to disclose their shareholding (both own or held by / for other persons on a beneficial basis) in the listed company in which they are proposed to be appointed as directors, prior to their appointment. These details should be disclosed in the notice to the general meeting called for appointment of such director

(F) Management

(i) As part of the directors' report or as an addition thereto, a Management Discussion and Analysis report should form part of the Annual Report to the shareholders. This Management Discussion & Analysis should include discussion on the following matters within the limits set by the company's competitive position:

- i. Industry structure and developments.
- ii. Opportunities and Threats.
- iii. Segment-wise or product-wise performance.
- iv. Outlook
- v. Risks and concerns.
- vi. Internal control systems and their adequacy.
- vii. Discussion on financial performance with respect to operational performance.
- viii. Material developments in Human Resources / Industrial Relations front, including number of people employed.

(ii) Senior management shall make disclosures to the board relating to all material financial and commercial transactions, where they have personal interest, that may have a potential conflict with the interest of the company at large (for e.g. dealing in company shares, commercial dealings with bodies, which have shareholding of management and their relatives etc.)

Explanation: For this purpose, the term "senior management" shall mean personnel of the company who are members of its core management team excluding the Board of Directors). This would also include all members of management one level below the executive directors including all functional heads.

(G) Shareholders

(i) In case of the appointment of a new director or re-appointment of a director the shareholders must be provided with the following information:

- (a) A brief resume of the director;
- (b) Nature of his expertise in specific functional areas;
- (c) Names of companies in which the person also holds the directorship and the membership of Committees of the Board; and
- (d) Shareholding of non-executive directors as stated in Clause 49 (IV) (E) (v) above

*(ia) Disclosure of relationships between directors inter-se shall be made in the Annual Report, notice of appointment of a director, prospectus and letter of offer for issuances and any related filings made to the stock exchanges where the company is listed. **[*Inserted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2008/08/04 dated 08/04/2008]**

(ii) Quarterly results and presentations made by the company to analysts shall be put on company's web-site, or shall be sent in such a form so as to enable the stock exchange on which the company is listed to put it on its own web-site.

(iii) A board committee under the chairmanship of a non-executive director shall be formed to specifically look into the redressal of shareholder and investors complaints like transfer of shares, non-receipt of balance sheet, non-receipt of declared dividends etc. This Committee shall be designated as 'Shareholders/Investors Grievance Committee'.

(iv) To expedite the process of share transfers, the Board of the company shall delegate the power of share transfer to an officer or a committee or to the registrar and share transfer agents. The delegated authority shall attend to share transfer formalities at least once in a fortnight.

V. CEO/CFO certification

The CEO, i.e. the Managing Director or Manager appointed in terms of the Companies Act, 1956 and the CFO i.e. the whole-time Finance Director or any other person heading the finance function discharging that function shall certify to the Board that:

(a) They have reviewed financial statements and the cash flow statement for the year and that to the best of their knowledge and belief :

- (i) these statements do not contain any materially untrue statement or omit any material fact or contain statements that might be misleading;
- (ii) these statements together present a true and fair view of the company's affairs and are in compliance with existing accounting standards, applicable laws and regulations.

(b) There are, to the best of their knowledge and belief, no transactions entered into by the company during the year which are fraudulent, illegal or violative of the company's code of conduct.

*(c) They accept responsibility for establishing and maintaining internal controls for financial reporting and that they have evaluated the effectiveness of internal control systems of the company pertaining to financial reporting and they have disclosed to the auditors and the Audit Committee, deficiencies in

the design or operation of such internal controls, if any, of which they are aware and the steps they have taken or propose to take to rectify these deficiencies. (*Substituted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2006/13/1 dtd. 13/01/06)

* (d) They have indicated to the auditors and the Audit committee

(i) significant changes in internal control over financial reporting during the year;

(ii) significant changes in accounting policies during the year and that the same have been disclosed in the notes to the financial statements; and

(iii) instances of significant fraud of which they have become aware and the involvement therein, if any, of the management or an employee having a significant role in the company's internal control system over financial reporting. (*Substituted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2006/13/1 dtd. 13/01/06)

VI. Report on Corporate Governance

(i) There shall be a separate section on Corporate Governance in the Annual Reports of company, with a detailed compliance report on Corporate Governance. Non-compliance of any mandatory requirement of this clause with reasons thereof and the extent to which the non-mandatory requirements have been adopted should be specifically highlighted. The suggested list of items to be included in this report is given in **Annexure- I C** and list of non-mandatory requirements is given in **Annexure – I D**.

(ii) The companies shall submit a quarterly compliance report to the stock exchanges within 15 days from the close of quarter as per the format given in **Annexure I B**. The report shall be signed either by the Compliance Officer or the Chief Executive Officer of the company

VII. Compliance

(1) The company shall obtain a certificate from either the auditors or practicing company secretaries regarding compliance of conditions of corporate governance as stipulated in this clause and annex the certificate with the directors' report, which is sent annually to all the shareholders of the company. The same certificate shall also be sent to the Stock Exchanges along with the annual report filed by the company.

(2) The non-mandatory requirements given in **Annexure – I D** may be implemented as per the discretion of the company. However, the disclosures of the compliance with mandatory requirements and adoption (and compliance) / non-adoption of the non-mandatory requirements shall be made in the section on corporate governance of the Annual Report.

Annexure I D

Non-Mandatory Requirements

(1) The Board

*A non-executive Chairman may be entitled to maintain a Chairman's office at the company's expense and also allowed reimbursement of expenses incurred in performance of his duties. Independent Directors may have a tenure not exceeding, in the aggregate, a period of nine years, on the Board of a company. The company may ensure that the person who is being appointed as an independent director has the requisite qualifications and experience which would be of use to the company and which, in the opinion of the company, would enable him to contribute effectively to the company in his capacity as an independent director. [***Substituted vide SEBI circular no. SEBI/CFD/DIL/CG/1/2008/08/04 dated 08/04/2008**]

(2) Remuneration Committee

- i. The board may set up a remuneration committee to determine on their behalf and on behalf of the shareholders with agreed terms of reference, the company's policy on specific remuneration packages for executive directors including pension rights and any compensation payment.
- ii. To avoid conflicts of interest, the remuneration committee, which would determine the remuneration packages of the executive directors may comprise of at least three directors, all of whom should be non-executive directors, the Chairman of committee being an independent director.
- iii. All the members of the remuneration committee could be present at the meeting.
- iv. The Chairman of the remuneration committee could be present at the Annual General Meeting, to answer the shareholder queries. However, it would be up to the Chairman to decide who should answer the queries.

(3) Shareholder Rights

A half-yearly declaration of financial performance including summary of the significant events in last six-months, may be sent to each household of shareholders.

(4) Audit qualifications

Company may move towards a regime of unqualified financial statements.

(5) Training of Board Members

A company may train its Board members in the business model of the company as well as the risk profile of the business parameters of the company, their responsibilities as directors, and the best ways to discharge them.

(6) Mechanism for evaluating non-executive Board Members

The performance evaluation of non-executive directors could be done by a peer group comprising the entire Board of Directors, excluding the director being evaluated; and Peer Group evaluation could be the mechanism to determine whether to extend / continue the terms of appointment of non-executive directors.

(7) Whistle Blower Policy

The company may establish a mechanism for employees to report to the management concerns about unethical behaviour, actual or suspected fraud or violation of the company's code of conduct or ethics policy. This mechanism could also provide for adequate safeguards against victimization of employees who avail of the mechanism and also provide for direct access to the Chairman of the Audit committee in exceptional cases. Once established, the existence of the mechanism may be appropriately communicated within the organization.

*50. The Company agrees mandatorily to comply with all the Accounting Standards issued by ICAI from time to time. [*Newly inserted Clause vide SEBI circular SMDRP /POLiCY/Cir-44/01 dated 31.08.2001]

*51. **EDIFAR FILING** [*Newly inserted Clause vide SEBI circular SMD/POLiCY/Cir-13/2002 dated 20.6.2002]

*(1) The company agrees that it shall file the following information, statements and reports on the Electronic Data Information Filing and Retrieval (EDIFAR) **web site maintained by National Informatics Centre (NIC)**, on-line, in such manner and format and within such time as may be specified by SEBI. [***Amended vide SMD/POLiCY/CIR.17/02 dated 03.07.2002**]

- Full version of annual report including the balance sheet, profit and loss account, director's report and auditor's report; cash flow statements; half yearly financial statements quarterly financial statements.
- Corporate governance report.
- Shareholding pattern statement.
- Statement of action taken against the company by any regulatory agency.
- Such other statement, information or report as may be specified by SEBI from time to time in this regard.

Provided that the requirement of this clause shall be in addition to and not in derogation from the requirements of other clauses of this listing agreement, which may require filing of any statements, reports and information in the physical or other form with the exchange.

(2) The company agrees that it shall appoint a compliance officer who shall be responsible for filing the above information in the EDIFAR system. The compliance officer and the company shall ensure the correctness and authenticity of the information filed in the system and that it is in conformity with applicable laws and terms of the listing agreement.

(3) The company undertakes that while filing the information in the EDIFAR system, it shall make the following disclaimer clause:

(4) *Notwithstanding anything in sub-clauses (1), (2) and (3), the company need not file on the EDIFAR website, any information, statement or report which has already been filed on the Corporate Filing and Dissemination System in pursuance of clause 52. [***Inserted vide SEBI circular no. SEBI/CFD/DIL/LA/4/2007/27/12 dated 27/12/2007**]

"The information furnished above is certified by (company's name) to be true, fair and accurate (except in respect of errors in or omissions from documents filed electronically that result solely from electronic transmission errors beyond our control and in respect of which we take corrective action as soon as it is reasonably practicable after becoming aware of the error or the omission).

SEBI, the Stock Exchanges or the NIC do not take any responsibility for the accuracy, validity, consistency and integrity of the data entered and updated by it.” The Name of the compliance officer with his designation and the company’s name shall be displayed immediately below the disclaimer clause.”

NOTE: The manner and format has been provided in the Operational Manual available on the SEBI web site.

***52. Corporate Filing and Dissemination System (CFDS), viz., www.corpfiling.co.in [*Inserted vide SEBI circular no. SEBI/CFD/DIL/LA/4/2007/27/12 dated 27/12/2007]**

(1) The company agrees -

- (a) to file on the CDFS, such information, statements and reports as may be specified by the Participating Stock Exchanges in this regard.
- (b) that the Compliance Officer, appointed under clause 47(a) and the company shall be responsible for ensuring the correctness, authenticity and comprehensiveness of the information, statements and reports filed under this clause and also for ensuring that such information is in conformity with the applicable laws and the listing agreement.”
- (c) to ensure that the electronic filing of information through CFDS, pursuant to compliance with any clause of the listing agreement, shall be done within the time limit specified in the respective clause of the listing agreement.
- (d) to put in place such infrastructure as may be required to comply with the clause.

Explanation: For the purposes of this clause –

- (i) The term “Corporate Filing and Dissemination System (CFDS)” shall mean the portal at the URL www.corpfiling.co.in or such other website as may be specified by the participating stock exchanges from time to time to take care of exigencies, if any.
- (iii) The term “Participating Stock Exchanges” shall mean the stock exchanges owning and maintaining CFDS.”

53. *The Company agrees that while making issue of debt securities on a private placement basis and listed on a stock exchange, it shall comply with the following:-

- 1.1. The company shall make full disclosures (initial and continuing) in the manner prescribed in Schedule II of the Companies Act, 1956, SEBI (Disclosure and Investor Protection) Guidelines, 2000 and the Listing Agreement with the exchanges. However, if the privately placed debt securities are in standard denomination of Rs.10 Lakhs, such disclosures may be made only through web sites of the stock exchange where the debt securities are sought to be listed.
- 1.2. The debt securities shall carry a credit rating of not less than investment grade from a Credit Rating Agency registered with the Board.
- 1.3. The company shall appoint a debenture trustee registered with SEBI in respect of the issue of the debt securities.
- 1.4. The debt securities shall be issued and traded in demat form.
- 1.5. The company shall sign a separate listing agreement with the exchange in respect of debt securities and comply with the conditions of listing.
- 1.6. All trades with the exception of spot transactions, in a listed debt security, shall be executed only on the trading platform of a stock exchange.
- 1.7. The trading in privately placed debts shall only take place between Qualified Institutional Investors (QIBs) and High Networth Individuals (HNIs), in standard denomination of Rs.10 lakhs.
- 1.8. The requirement of Rule 19(2)(b) of the Securities Contract (Regulation) Rules, 1957 will not be applicable to listing of privately placed debt securities on exchanges, provided all the above requirements are complied with.
- 1.9. If the intermediaries registered with SEBI associate themselves with the issuance of private placement of unlisted debt securities, they will be held accountable for such issues. They will also be required to furnish periodical reports to SEBI in such format as may be decided by SEBI. [*Inserted vide SEBI Letter No. SEBI/MRD/SE/AT/36/2003/30/09 Dtd. 30/09/2003]

***Clarifications: [Amended vide SEBI Letter no. SEBI/MRD/SE/AT/46/2003 dtd. 22/12/2003]**

1 Applicability of the circular

i. Type of Issuer companies

a) The SEBI circular dated September 30, 2003 would be applicable to all listed companies which have any of their securities, either equity or debt, offered through an offer document, i.e., through a public issue and listed on a recognized stock exchange and also includes Public Sector Undertakings whose securities are listed on a recognized stock exchange.

b) Further, unlisted companies/statutory corporations/other entities, if they so desire, may get their privately placed debt securities listed in the stock exchanges, by complying with the relevant provisions of the said circular.

ii. Prospective and existing issues

a) The SEBI circular is applicable to all debt securities that have been and would be issued on a private placement basis on or after the date of the circular, i.e., September 30, 2003.

b) The circular would also apply to those issuer companies whose outstanding debt securities were issued prior to September 30, 2003. However, such issuer companies are required to comply with the provisions of the circular before March 31, 2004 for which transition time was provided vide press release dated November 25, 2003.

c) If, however, the issuer companies do not comply with the aforesaid conditions for listing of such securities before March 31, 2004, then such securities would remain unlisted and, would, therefore, not be permitted for trading in the Stock Exchange trading platform from April 01, 2004.

iii. Tenor of the debt instruments

The SEBI circular would not be applicable for private placement of debt securities having a maturity of less than 365 days.

2 Extent of disclosures and applicability of DIP Guidelines

a) As already stipulated in the circular dated September 30, 2003 the issuer companies shall make full disclosures (initial and continuing) in the manner prescribed in Schedule II of the Companies Act, 1956, Chapter VI of the SEBI (DIP) Guidelines, 2000 and the listing agreement with the stock exchanges.

b) Such disclosures may be made through the web site of the stock exchanges where the debt securities are sought to be listed if the privately placed debt securities are issued in the standard denomination of Rs. 10 lakhs.

c) The issuer companies which make frequent private placements of debt securities would be permitted to file an umbrella offer document on the lines of a "Shelf prospectus" as applicable for a public issue.

d) As regards financial disclosures, issuer companies which are not in a position, for genuine reasons, to disclose audited accounts upto a date not earlier than six months of the date of the offer document, in terms of provisions of Clause 6.18 of SEBI (DIP) Guidelines, 2000 may disclose the audited accounts for the last financial year and unaudited accounts for the subsequent quarters with a limited review by a practicing Chartered Accountant.

e) It is also being clarified that the provisions other than Chapter VI of SEBI (DIP) Guidelines, 2000 will not be applicable for privately placed debt securities.

3 Association of SEBI registered intermediaries, including merchant bankers

a) The appointment of intermediaries (other than debenture trustee) for private placement of debt securities is not mandatory.

b) Since engaging the services of an intermediary (other than debenture trustee) is not mandatory, the appointment of such an intermediary would be left to the discretion of the issuer company, as it deems fit.

c) There is no prohibition on SEBI registered intermediaries to be associated with the privately placed unlisted debt securities. However, such intermediaries would be accountable for their activities. Further, they would be required to furnish periodical reports to SEBI in such format as specified by SEBI from time to time.

4 Vetting of offer document

There is no requirement of vetting of the offer document by SEBI.

5 Whether the requirement of 1% deposit with the stock exchange/s is mandatory

There is no requirement to deposit 1% of the issue size of the privately placed debt securities with the stock exchanges.

6 Applicability of minimum subscription clause as per DIP guidelines

This clause will not be applicable for privately placed debt securities.

7 Credit rating

The debt securities shall carry a credit rating from a Credit Rating Agency registered with SEBI.

8 Listing through a separate listing agreement

The separate Listing Agreement for listing the privately placed debt securities is being finalised. Till such time, the issuance process would be allowed and the securities may be listed on the basis of disclosures subject to the issuer company furnishing an undertaking to the Stock Exchanges stating, inter-alia, that the issuer company shall sign the Listing Agreement as soon as the same comes into force.

9 Denomination for issuance and market lot for trading

a) The privately placed debt securities need not necessarily be issued in denomination of Rs. 10 lakhs.

b) The securities shall be issued in demat form.

c) However, if an investor is allotted securities of Rs.1 lakh or less, such securities may be issued in physical form at the option of the investor. It shall be disclosed by the issuer companies that such investors would not be able to trade in such securities through the stock exchange mechanism.

10 Trading of securities on the stock exchanges

a) The trading in the privately placed debt securities would be permitted in standard denomination of Rs. 10 lakhs in the anonymous, order driven system of the stock exchanges in a separate trading segment. The marketable lot would be Rs. 10 lakhs.

b) All class of investors would be permitted to trade subject to the said standard denomination/marketable lot.

c) The trades executed on spot basis shall be required to be reported to the stock exchange/s.

*The company agrees that it shall facilitate the recognized stock exchange (including the Exchanges having nationwide access), for setting up and maintaining a corporate bond trading and reporting

platform and comply with the requirements of corporate bond market as per Annexure – B herebelow and such other requirements as may be laid down by the Exchange (including the Exchange having nationwide access) and SEBI, from time to time, on a continuous basis. **[Amended vide SEBI Circular no. SEBI/CFD/DIL/BOND/1/2006/12/12 dtd. 12/12/2006, as approved by circular resolution dtd. 22/01/2007 of ASEL Board of Directors]**

54. “The Company agrees that it shall ensure the following: -

That with effect from February 1, 2005:

- a. No investor would be required to pay any charge towards opening of a beneficiary Owner (BO) Account except for statutory charges as may be applicable;
- b. No investor would be required to pay any charge for credit of securities into his/her BO account; and
- c. No custody charge would be levied on any investor who would be opening a BO account on or after February 1, 2005.

The Company further agrees that it shall ensure the following that w.e.f. April 1, 2005, the custody charges would not be levied on any investor/ shareholder and it shall pay the charges towards custody to the depositories, on a per folio (ISIN position) basis as at the end of the financial year, according to the table given below:

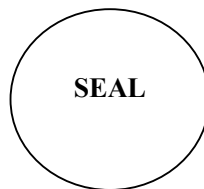

- I. SEBI decided that Bombay Stock Exchange Limited would be setting up and maintaining a corporate bond reporting platform and for this purpose, the following shall be implemented with effect from January 1, 2007.
1. The term 'Corporate Bonds' for this purpose shall include all listed debt securities issued by institutions such as Banks, Public Sector Undertakings, Municipal Corporations, bodies corporate and companies.
 2. All issuers, intermediaries and contracting parties shall be granted access to the corporate bond reporting platform for reporting of trades. Where transactions are executed through the intermediary, reporting responsibility shall lie with the intermediary. If executed otherwise, reporting will be made either through an authorized intermediary or directly by the contracting parties.
 3. All transactions in corporate bonds of the value of Rs. 1,00,000 or above are required to be reported to the corporate bond platform. The transactions shall be reported within 30 minutes of closing the deal. The information on settlement shall be reported by the parties involved in the transaction within 1 trading day from completion of the settlement.
 4. The Bombay Stock Exchange Limited (BSE) shall ensure that the Corporate Bond Reporting platform for the purpose shall be available from 10.00 am to 5.30 pm on all trading days.
 5. The access to the Platform for the purpose of reporting will be given to all market intermediaries who approach BSE for the purpose. The connectivity to the non-members of the Exchange would be enabled through Virtual Private Network (VPN).
 6. The BSE shall populate the data reported on their platform on their website on a real time basis for information of investors/public.
 7. Since the platform is purely for reporting purposes, the stock exchange shall have no role or liability for settlement of these trades. The intermediaries / contracting parties shall settle the trades bilaterally.
 8. Issuers are required to disclose / update regularly all material information such as rating obtained on the instruments and the rating migrations as and when they take place, record date, reasons for record date, put/call option dates, units exercised under put/call option etc, failing which action may be initiated against the issuer and or its directors/promoters.
- II. Applicability:
1. The reporting shall be made for all trades in listed debt securities issued by all institutions such as Banks, Public Sector Undertakings, Municipal Corporations, bodies corporate and companies.
 2. The reporting of trades in Corporate Bonds shall be made by all person(s) dealing in such corporate bonds irrespective of whether they are SEBI registered intermediaries or otherwise.
