Sub: - SCORES Authentication for listed companies

Please refer to SEBI circular no. CIR/OIAE/1/2013 dated April 17, 2013 stipulating that all companies which are listed on any Stock Exchange must redress the grievances of investors and inform them within 30 days of receipt of complaints. The details of investor grievances relating to the respective companies are available at the webpage <http://scores.gov.in/admin>, accessed through the respective SCORES user ID and password of each company.

Further, the circular also directs all the listed companies which are yet to obtain SCORES user ID and password to obtain the SCORES user ID and password within 30 days of issue of this circular i.e. by May 17, 2013.

Please note that Stock Exchanges are accordingly advised by the aforesaid circular to bring the provisions of this circular to the notice of all the companies whose securities are listed in the exchanges and to disseminate the same through their websites. Further, the Stock Exchanges should also arrange for adequate publicity of this circular through various means, on urgent basis.

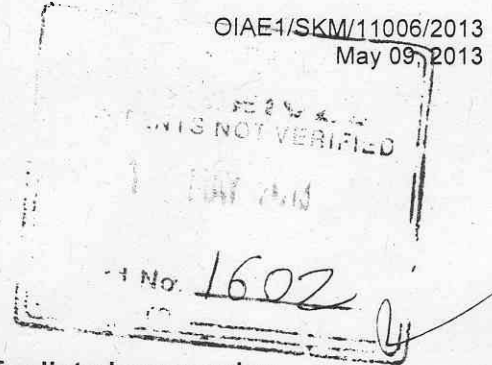
As per data available with SEBI, it is observed that 1068 such companies are listed with your exchange which has not obtained SCORES authentication so far. A list of these companies is attached as Annexure.

You are advised to take necessary steps to make sure that all companies listed with your exchange obtain SCORES authentication as per time specified in the circular i.e. till May 17, 2013. You are also advised to send a report on the same to SEBI till May 25, 2013.
